Personal Information Greatbend.com Gathers

Information You Give Us:

We only collect or maintain the private and personally identifiable information (such as name, address or email address) that you voluntarily provide to Greatbend.com, either via email or when registering to use the greatbend.com free directories, free newsletter or other features.

We only use the information you provide to customize the content, layout and/or features of our website for you. None of your private and personally identifiable information is sold, licensed or shared with any third party for commercial purpose. Registration is not required to use the basic features of greatbend.com however if you wish to enter your business in the free directory, it is.

Automatic Information:

Our web server automatically receives and stores certain types of non-personally identifying information whenever you interact with greatbend.com. This information includes the domain name or Internet protocol (IP) address used to connect your computer to the Internet; computer and connection information, such as web browser type and version, operating system and platform (such as Windows/ Macintosh); the full Uniform Resource Locators (URL) of pages linking to, within or from our website, including date and time. This information is reviewed and is used internally to determine what web pages users access or visit on greatbend.com. Our use of web browser cookies is limited to customizing website content and ensuring authenticity of a user who has been given use of a data-driven page that requires content management by the end users.
